### Agenda

T. Frierson (IL) made a motion to approve the agenda as presented. The motion passed by unanimous consent.

#### Minutes

C. Biehn (IN) made a motion to approve the minutes as amended from the meeting on January 28, 2025. The motion passed.

#### **Unfinished Business**

Review comments submitted for Rule 4-104: Authority to Accept/Deny Supervision and Rule Committee recommendations

- Chair J. Rader (NE) presented the comments submitted for the Midwest Region rule amendment proposal for Rule 4-104: Authority to Accept/Deny Supervision.
- Chair J. Rader (NE) shared that the Rules Committee voted 8-0-0 to suggest that the Midwest Region consider substituting the word "enforce" for the word "meet" in two locations in the rule proposal and consider whether the proposal might have an unintended consequence of increasing supervision denials. The Rules Committee also recommended that the Midwest Region clarify the justification section or add language to indicate that the inability of the receiving state to enforce/meet a condition is not a valid reason for denial.
- A. Christian (NE) stated that she discussed concerns about using the term "meet" with Rules Committee Chair, J. Hawkins (MO), who suggested using the term "provide."
- The relevant section of the proposed rule amendment for Rule 4-104 (6) would state, "A receiving state that is unable to provide any condition of supervision imposed by the sending state shall notify the sending state of its inability to provide the condition(s) by documenting the conditions which cannot be provided on the Form VIII, Home Evaluation Report."
- C. Frieberg (SD) made a motion to approve the change in the proposed rule amendment from "enforce" to "provide." The motion passed by unanimous consent.
- A. Christian (NE) recommended adding the following statement to the success statement in the justification section of rule proposal, "The inability of the receiving state to provide any condition of supervision imposed by the sending state would not be a valid reason for supervision to by denied by the receiving state."
- C. Gerber (WI) made a motion to add the recommended statement to the rule amendment justification success statement. The motion passed by unanimous consent.

## **New Business**

# Provide Feedback on Removal of Compliance Standards

- Representative J. Rader (NE) stated that the Compliance Committee recommended removing Standards A-07 and Standard A-11 because UNITY was designed to ensure compliance through task requirements and date restrictions, and cases can only progress if they met the requirements described in Standards A-07 and A-11.
- Standard A-07 states: "With regard to probation cases, Sending States shall ensure referral documents are complete and forwarded to the receiving state. (Rule 4-102(2)(b))."
- Standard A-11 states: "Travel permits shall not exceed 90 calendar days. (Rule 8-101(3))."
- No feedback provided.

Conduct Poll to Increase Awareness of State Human Trafficking Screening Practices and Resources

- C. Frieberg (SD) stated the Racial Diversity, Equity, and Inclusion (RDEI) Committee is exploring
  ways to more accurately capture data that tracks instances of human trafficking. The
  committee's goal is to encourage all ICJ Offices to learn about and/or develop their
  procedures for identifying human trafficking concerns. He shared that the RDEI Committee
  was conducting a poll in each region to gather information regarding state human trafficking
  screening and data collection practices.
- The poll developed by the RDEI Committee was conducted.

## Review Ohio's Human Trafficking Screening Project

• S. Lane (OH) outlined Ohio's new human trafficking screening project, with plans to implement a screening tool for every youth entering or leaving the state. She stated she will email the Midwest Region members and encouraged members to provide feedback and suggestions on this project.
