#### Agenda

- A. Connor (ID) made a motion to approve the agenda as presented. The motion passed.
- A. Connor (ID) made a motion to approve the minutes of the meeting on June 13, 2025, as presented. The motion passed.

### **Orientation for New Partners**

- Chair C. Bickford (NH) presented an introduction to the Interstate Commission for Juveniles and shared the purpose and charge of the Work Group on Returning Non-Delinquent Youths.
- Chair C. Bickford (NH) shared the key findings from the *Top Concerns for Returning Non-Delinquent Runaways Survey Report* (2024).
- Chair C. Bickford (NH) reported that the Work Group was initially convened in January 2025 and had focused primarily on exploring challenges related to sharing information

about the circumstances in which the youth was found. The group developed the following "ideal statement" to guide its remaining efforts.

- o "We cultivate a system of care rooted in collaboration, trust, shared voice, and a shared purpose, where law enforcement, child welfare, and stakeholder ambassadors unite to champion safe return and wellbeing of non-delinquent runaway youth. Together, we nurture an inclusive environment where appropriate information flows openly, every voice is heard, and no young person falls through the cracks."
- Chair C. Bickford (NH) also shared desired cultural norms developed by the Work Group.

## **National Resources and Requirements**

- R. Curtis (ME) presented information regarding the functions of state compact offices.
- A. Whitlock shared information about the National Runaway Safeline (NRS) and pending federal legislation to renew funding for related services. NRS's mission is to keep America's runaway, homeless, and at-risk youth safe and off the streets.

Dr. S. Sahl and K. Parks-Bourn presented information about the National Center for Missing and Exploited Children (NCMEC). Their mission is to find missing children, reduce child sexual exploitation, and prevent future victimization. They also shared information regarding federal requirements for reporting children missing from care of social services agencies, child sex trafficking, and related NCMEC resources.

# **Group Discussion and Reflection**

Participants separated into groups for scenario-based discussions. Several key themes
were noted, including the potential for increasing the use of children's advocacy centers
for interviewing non-delinquent runaways, particularly when abuse, neglect, and/or
human trafficking is suspected.
