Agenda

J. Hall (FL) made a motion to approve the agenda as presented. The motion passed by unanimous consent.

Minutes

Unfinished Business

- Representative Felicia Dauway (SC) opened the floor for discussion on any unfinished business, specifically pertaining to adult waivers for youth in juvenile facilities (Rule 7-104 (5).
- Members shared information regarding how their states handled cases involving young people
 housed in juvenile facilities whose agreement to voluntarily return is documented using forms
 used in adult cases, rather than using the ICJ Form III, Consent for Voluntary Return of Out-ofState Juvenile.

New Business

Discuss Rule Amendment Proposals

- Representative Felicia Dauway (SC) opened the floor for discussion of the rule amendment proposals.
- Members discussed the rule amendment process.
- Julie Hawkins (MO), Rules Committee Chair, highlighted options for future rule proposals. She encouraged participants to gather information and feedback through regional meetings and submit issues to the Rules Committee, who can provide guidance for proposal development.

Provide Feedback on the concept of extending the rules cycle to three (3) years

- Representative Felicia Dauway (SC) opened the floor for discussion on extending the rules cycles.
- Members highlighted the value of having sufficient time to assess the impact of the rule change before the next cycle and the importance of clarifying the process for enacting emergency rules.
- Tom Travis, Legal Counsel, provided insight as to the Rule 2-103, noting that the current rule would allow for an extension of the rules cycle and provides a process for enacting emergency amendments.

Review election process and candidate list

• Representative Felicia Dauway (SC) opened the floor for discussion and review of the election process and candidates list.

- Representative Felicia Dauway (SC) expressed appreciation for her re-election as South Regional Representative in 2024. She encouraged members to contact her with questions and concerns.
- Members expressed interests in learning more about the Commission's human resource management, contract-related processes, budgeting, and formula for calculation of dues.
- Felicia Dauway (SC) articulated that she will follow up with the National Office on the issues of interest.
- Felicia Dauway (SC) closed the discussion with reminders about the election process and who is currently seeking election.

Reports

Racial Diversity Equity and Inclusion (RDEI) Committee and Human Trafficking Poll Results

• Latosha Mallory (AL) provided a report on the human trafficking poll results and directed members to the memo provided prior to the meeting. She indicated that the RDEI Committee was working to increase ICJ offices' reporting of human trafficking concerns, perhaps by requiring the use of the human trafficking data field in UNITY.
